



**DECLARATION FORM  
For  
VGM CLUB MEMBER**

Whereas the Undersigned, hereinafter referred to as, "The Client", desires to be serviced under the terms and conditions of the VGM Club Uniform and Linen Rental Agreement with its designated linen provider, AlSCO Inc., located at 175 South West Temple, Suite 510, Salt Lake City, Utah, 84101, at The Client's location(s), The Client agrees to the additional following terms and conditions:

- 1. The pricing and service program offered under the VGM Club national agreement will be implemented in The Client's location(s) with an approved credit application on file.
- 2. The Client will be solely responsible for payment of charges in connection with the services provided by AlSCO, Inc. The Client shall pay all charges for merchandise within 15 days following the month in which delivery is made. The Client is also responsible for Finance Charges of 1.5% per month or 18 % per year on all outstanding balances 30 days or more past due until paid in full. Balances not made within 30 days of the due date, may also be subject to revoked credit privileges and deliveries on a C.O.D. basis only.
- 3. This Declaration Form shall remain in full force and effect for a period of 36 months, commencing on the date of installation of goods and shall be automatically renewed for consecutive 18 month periods thereafter unless either party shall give to the other party written notice of termination by registered mail at least 30 days prior to the expiration of the term then in effect.
- 4. The Client agrees that if AlSCO, Inc.'s linen and uniform rental service is terminated for any reason excluding AlSCO's inability to conduct business for the customer location, during the term of this Declaration Form, The Client shall purchase all goods in service at the replacement value listed in the VGM Club National Agreement, Schedule A-Pricing, depreciated by 3% per month of service up to and not to exceed 50% of the value of each item.
- 5. If The Client ceases to be a member of the VGM Club Purchasing Program, AlSCO, Inc. may discontinue the VGM Club pricing structure. The Client agrees that if the linen and uniform rental service with AlSCO, Inc. is also terminated in conjunction with the VGM program during any period of this Declaration Form, The Client shall purchase all goods in service at the replacement value listed in the VGM Club national agreement, Schedule A-Pricing, unless The Client retains the services of AlSCO under a service agreement between The Client and AlSCO, Inc.
